Personal data processing Informative

Informative note according to and for the effect of Section 13 of EU Reg.2016/679

In compliance with the REGULATION (EU) 2016/679 (GDPR) we provide the necessary information regarding the processing of your personal data. This notice is provided pursuant to art. 13 GDPR.

CATEGORIES OF PROCESSED DATA

Personal data: any information relating to an identified or identifiable natural person ('data subject'); an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person - art. 4, c. 1, n. 1 GDPR.
Particular data: any information revealing racial or ethnic origin, trade union membership, data concerning health or relating to criminal convictions and offences or related security measures as of d.P.R. n.313 14 November 2002, art. 3, co. 1, lett a) to o) and r) to u).

DATA CONFERRAL

Except from what specified on navigation data, the subject is free to furnish personal data. The provision of personal data is mandatory or optional depending on the purpose for which the data is processed. Whether data are not provided, the data processor won't be able to provide his services or what requested.

RECIPIENTS

In order to comply with on-duty contracts, your personal data will be processed by companies contractually linked to AVIONORD SRL, and could be communicated to others belonging to these categories:

- subjects providing services for the management of the information system used by AVIONORD SRL and telecommunications networks;
- freelancers, studies or companies in the context of assistance and consultancy relationships;
- platform operators for the abovementioned services (websites hosting, etc);

- subjects providing services for the abovementioned activities (e.g. communication, brochure, flyers, websites, ...)
- competent authority for the fulfilment of law obligations and/or public bodies upon request
- to other group members

Entities in the above categories are to be considered data processor, or are acting independently as data controller. If you provide your consent, your data could be diffused on AVIONORD SRL' web site. Any other communication or diffusion will take place with your expressed content

DATA TRANSFER TO A THIRD COUNTRY AND/OR INTERNATIONAL ORGANISATION

Personal data provided will be communicated to recipients contractually linked to AVIONORD SRL, also abroad within the European Union, in compliance with and within the limits set forth in art. 44 of the Reg. (EU) 2016/679; Data subject can request a copy of the processing conditions asking to the Human Resource office.

DATA SUBJECT RIGHTS

You may freely exercise your rights at any time contacting the Data Controller - email info@avionord.com. You have the right, at any time, to obtain from the Data Controller confirmation as to whether or not personal data concerning you are being processed, request their rectification, erasure or restriction of precessing.

Moreover you have the right, at any time, to oppose to your personal data processing without prejudice to lawfulness of processing.

Without prejudice to any other administrative or judicial remedy, in case you consider your data processing in contrast with Reg. UE 2016/679, pursuant to article 15 lett. f), you have the right to lodge a complaint with a supervisory authority and, pursuant to article 6 paragraph no. 1, lett. a) and article 9, paragraph no. 2, lett. a), you have the right to revoke your expressed consent at any time.

Exercising your right to data portability, the Data Controller may provide your personal data in a structured, commonly used and machine-readable format.

INFORMATIVE AMENDMENTS
